CLOSE SEASONS

Cockles	Throughout District - 1 February to 30 April
Oysters	Throughout District - 1 March to 31 October
(Separate regulations apply to Poole Harbour under the Regulating Order)	
Prawns	Poole Harbour - 1 January to 31 July
Winkles	Throughout District - 15 May to 15 September
Trawling	Chesil area - 1 May to 31 August
Clams	Poole Harbour - By licence only
Clams	There are various minimum sizes laid down depending on the species

Nets

A variety of mesh sizes are laid down for fixed and towed nets depending upon the species targeted.

Vessel Restrictions

The maximum size of vessels allowed to fish within the Southern IFCA District within 6 miles of Baselines is 12 metres overall length.

Any vessel fishing commercially within the District must be registered with the Authority.

Commercial Fishing

It is an offence to sell any sea fish caught from a vessel which is not correctly licensed and registered in accordance with current regulations.

ICES Areas

The border between areas VIId and VIIe is the 2° W line of longitude.
Area VIId is to the East of the line and Area VIIe is to the West.

Lobster/Crawfish

It is an offence to retain on board or land a lobster or crawfish which has a notch cut in its tail or which has a mutilated tail. No person shall remove from the fishery any Berried lobster of the species *Homarus gammarus*.

Scallop Fishing

a - When dredging for scallops (*Pecten maximus*) within any fishery the maximum number of dredges which may be towed at any time is twelve. All dredges must be fitted with a spring loaded tooth bar and the mouth of any dredge must not exceed 85 cm in overall width. No more than two tow bars may be used at any time and the maximum length of any tow bar shall not exceed 5.18 metres including attachments.

b - No person shall fish for or take any scallop from any fishery on any day before 0700 local time and after 1900 local time.
